What is this product?

Type

Unit linked investment fund. The value of the Vitality Invest Life Insurance Policy may be linked to this fund.

Objectives

The Fund aims to provide income with the opportunity for capital growth by investing primarily in the shares of UK companies. The Fund may sometimes invest in a relatively small number of companies.

The Fund may invest in other assets such as cash, other funds and derivatives (financial contracts whose value is linked to the price of an underlying asset).


The Fund's returns depend on the returns of its underlying investments as reflected in the Fund's price (the value of its assets, less any liabilities, divided by the number of the Fund's shares).

Intended retail investor

This Fund has been designed to form part of a broader portfolio of investments. The Fund is intended for investors who would like to spread their investment over a range of different equities that are listed in the UK, as decided by the fund manager. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least five years.

What are the risks and what could I get in return?

Summary Risk Indicator:



The risk indicator assumes you keep the product for 5 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this fund compared to other funds. It shows how likely it is that the fund will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential for future losses at a medium level, and poor market conditions could impact our capacity to pay you.

This fund does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme. The indicator shown above does not consider this protection.

What are the costs?

Costs over time

The Reduction in Yield (RIY) shows the impact the total costs you pay will have on the investment return you might get. The total costs take into account any one-off, ongoing and incidental costs for the fund.

The amounts shown here are the cumulative costs of the fund, for three different holding periods. The figures assume you invest £10,000. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

Recommended minimum holding period: 5 Years
